- 7. Began work on two grants available through the Illinois State Library focused on recovery from the pandemic. Priority is on the Library Spaces grant if we cannot finish both. If awarded, grant funded activities begin October 1, 2021.
 - On the Road to Recovery: Transforming Library Spaces this one is specifically for
 restoring the library's capacity to operate with clean safe spaces for patrons. I am
 working with Kathy Clark to choose furniture that is easily cleaned, more flexible and
 mobile for spacing for social distancing when needed, and convenient for patrons using
 the Library's Wi-Fi. We especially hope to replace the eight upholstered chairs with new
 seating.
 - Expanding Digital Inclusion: Transforming Library Services this one is specifically for devices that circulate to meet patrons' needs. We are looking at hotspots, laptops, webcams, and Launchpads (locked down tablets with preloaded learning activities and games).

8. Insurance policy vs. Bond for Treasurer's position.

From the Illinois Compiled Statutes:

75 ILCS 16/30-45

Duties of Officers

(e) As an alternative to a personal bond on the treasurer, the treasurer may secure for the district an insurance policy or other insurance instrument that provides the district with coverage for negligent or intentional acts by district officials and employees that could result in the loss of district funds. The cost of any such coverage shall be borne by the district.

9. Revision of Board of Trustees Bylaws

From the Illinois Compiled Statutes:

5 ILCS 120/7

In summary - the traditional remote meeting process in the Open Meetings Act allows public bodies to adopt rules to allow a member to participate by video or audio conference when a physical quorum is present at the meeting so long as the member is prevented from physically attending because of: (i) personal illness or disability; (ii) employment purposes or the business of the public body; or (iii) a family or other emergency. The remote member must notify the recording secretary or clerk of his or her physical absence ahead of time, unless impractical, and a majority of the public body then approves allowing the remote member's participation by video or audio conference.
