ORDINANCE 2018-4

ANNUAL BUDGET AND APPROPRIATION ORDINANCE FOR THE FISCAL YEAR BEGINNING THE 1ST DAY OF JULY, 2018 AND ENDING THE 30TH DAY OF JUNE, 2019

WHEREAS, The Board of Trustees of the Bethalto Public Library District, Madison County, Illinois, has prepared or caused to be prepared a tentative form of the Annual Budget and Appropriation for said Library District for the fiscal year beginning July 1, 2018 and ending June 30, 2019 and the same has been conveniently available for public inspection for at least thirty (30) days prior to final action thereon; and

WHEREAS, a public hearing was held as to such Annual Budget and Appropriation Ordinance on September 20, 2018, notice of which was given at least thirty (30) days prior thereto; and

WHEREAS, all other legal requirements have been duly complied with by the Board of Trustees of the Bethalto Public Library District;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE BETHALTO PUBLIC LIBRARY DISTRICT, IN THE COUNTY OF MADISON AND STATE OF ILLINOIS, AS FOLLOWS:
