Ordinance No. 2018-2

Whereas, the State of Illinois has enacted "An Act regulating wages of laborers, mechanics and other workers employed in any public works by the state, county, city, or any public body or any political subdivision or by anyone under contract for public works," approved June 26, 1941, as amended, being 820 ILCS 130/0.01 et seq.; and

Whereas, the aforesaid Act requires that the Bethalto Public Library District of the County of Madison, State of Illinois, investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics, and other workers in the locality of said Bethalto Public Library District employed in performing construction of public works, for said Bethalto Public Library District.

Now, therefore, be it ordained by the President and Board of Trustees of the Bethalto Public Library District:

Section I. To the extent and as required by "An Act regulating wages of laborers, mechanics, and other workers employed in any public works by the state, county, city or any public body or any political subdivision or by anyone under contract for public works", approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics, and other workers engaged in the construction of public works coming under the jurisdiction of the Bethalto Public Library District is hereby ascertained to be the same as the prevailing rate of wages for construction work in Madison County as determined by the Department of Labor of the State of Illinois as of June 2018, a copy of that determination being attached hereto and incorporated herein by reference. As required by said Act, any and all revisions of the prevailing rate of wages by the Department of Labor and of the State of Illinois shall supersede the Department's June determination and apply to any and all public works construction undertaken by the Bethalto Public Library District. The definition of any terms appearing in this Ordinance which are also used in the aforesaid Act shall be the same as in said Act.

Section 2. Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of this Bethalto Public Library District to the extent required by the aforesaid Act.

Section 3. The Secretary of the Bethalto Public Library District Board of Trustees shall publicly post or keep available for inspection by any interested party in the main office of this Library District this determination or any revisions of such prevailing rate of wage. A copy of this determination or of the current revised determination of prevailing rate of wages then in effect shall be attached to all contract specifications.

Section 4. The Secretary of the Bethalto Public Library District Board of Trustees shall mail a copy of this determination to any employer, to any association of employers, and to any person or association of employees who have filed their names and addresses requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

Section 5. The Secretary of the Bethalto Public Library District Board of Trustees shall promptly file a certified copy of this Ordinance with the Department of Labor of the State of Illinois.

Section 6. The Secretary of the Bethalto Public Library District Board of Trustees shall cause to be posted on the website of the Bethalto Public Library District a notice of this Ordinance and such publication shall constitute notice that the determination is effective and that this is the determination of this public body.

Section 7. This Ordinance shall be in full force and effect from and after its passage.
